

2012 Bullards Bar Recreation Area Camping Terms and Regulations

General:

- Camping permits are required if staying overnight at an assigned campground, anywhere on shore or overnight on a boat that is not a current tenant of Emerald Cove Marina.

Reservations, Fees & Payments:

- \$7.50 reservation handling fee applies per campsite
- 2 night minimum if arriving on Friday or Saturday. 3 night minimum for holiday weekends.
- Campsite reservations are to be paid in full at the time of booking.
- We accept Visa or Mastercard for telephone reservations.
- Reservation handling fees and/or re-booking (change) fees are not refundable.

Re-Booking Policy:

- Reservation changes may be made up until 4 days in advance of your original "check in" date.
- No changes or rescheduling will be honored within 4 days of the "check in" date.
- A "Re-Booking" fee of \$7.50 per site will apply.
- A reservation may be changed only once. After the reservation has been changed or modified, all fees become NON-Refundable. No additional changes will be accepted after the first change.

Cancellation and Refund Policy:

- Cancellations made more than 30 days before the check-in date will receive a full refund of the camping use fees per site cancelled.
- If the cancellation is within 30 days, but more than four (4) days prior to the check-in date, a penalty of one night's campsite use fee will apply and a refund in the amount of the difference will be issued.
- No refund of fees for a cancellation within four (4) days of the check-in date.
- No refund of fees if a reservation has been previously changed.
- No refunds due to poor weather, acts of nature, or any undesirable condition beyond our control.

Camping Permits:

- Your camping permit is the reservation "Confirmation" letter you received. This is to be posted at your site during the duration of your stay. Occupying a campsite without a permit risks being cited by the U.S. Forest Service.
- Shoreline and overnight boat camp permits must be picked up at the Emerald Cove Marina office.

Campground Check-In and Check-Out time is 2:00pm daily:

- If you do not have a permit or confirmation letter, make sure to obtain one BEFORE occupying any campsite. Occupying a campsite without a permit risks being cited.
- Please do your part in leaving the campsite in good condition. Please remove and properly dispose of all trash. Please remember not to leave any personal belongings or consumables behind.

General Camping Rules:

- Enforced by county ordinance, "Quiet Time" is from 10pm to 6am. Please respect your neighbors.
- Campground regulations, occupancy limits, vehicle limits, and noise ordinances are strictly enforced and patrolled by the U.S. Forest Service.
- Regulations specific to a campground are posted including vehicle parking guidelines on the campground bulletin board.
- Campfires are only allowed with a camping permit. Restrictions may apply. For campfire restriction information, contact Emerald Cove Marina or visit www.bullardsbar.com.
- When in doubt about a rule, please use common sense and courtesy as your guide. If you experience problems upon arrival or during any time during your stay, please ask a member of the Forest Service or Emerald Cove Marina staff for assistance.
